

# ABOUT US

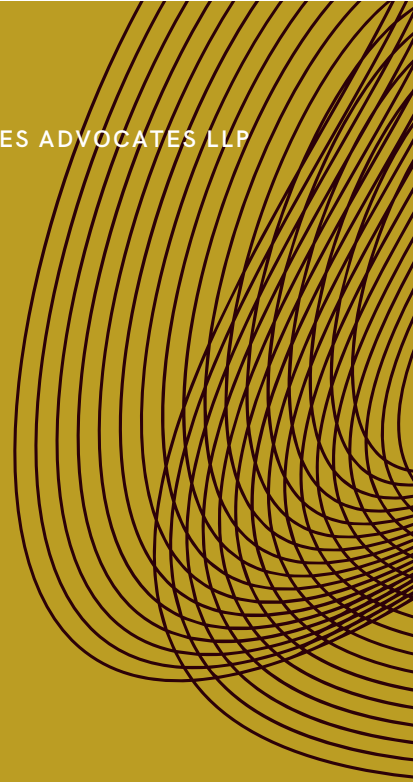
Isoe and Associates Advocates is a pre-eminent Law Firm in Kenya that provides legal assistance to a wide variety of clients with different needs and preferences.
